It will also address sustainability solutions and will end the session with Q&As.

UNOPS helps people build better lives and countries achieve sustainable development. UNOPS brings to this task the values and principles of the United Nations and the innovation, boldness, speed and efficiency of a self-financed institution. UNOPS provides practical solutions to assist its partners to save lives, protect people and their rights. UNOPS is quite advanced in sustainable procurement.

In this presentation, participants will receive a general overview of procurement opportunities arising from the World Bank's annual lending activities, which exceed \$30 billion. What are the roles of the World Bank in the contracting process? What regions, countries, and sectors does the World Bank focus on? How is the World Bank different from other UN organizations, and how should this change companies' approach to bidding on opportunities? This year, in particular, this session will focus on implementing the reform of the World Bank's procurement policies and guidelines.

### INDUSTRY PANEL: LOGISTICS AND TRANSPORTATION

Logistics and transportation remain among the largest and most critical areas of UN procurement. This panel will examine how the UN agencies organize its global supply chains to deliver goods and services efficiently across diverse and often challenging environments. The session will explore how companies can position themselves to respond effectively to UN tenders, including aligning their supply chains with UN operational requirements. Participants will gain a clearer understanding of

where demand is concentrated, the types of services required, and the qualifications needed to compete in this space.
